IN 2007, THE DC BAR FOUNDATION (DCBF) BEGAN AWARDING ACCESS TO JUSTICE GRANTS WHEN THE DC COUNCIL DESIGNATED DCBF AS THE ADMINISTRATOR OF THE ACCESS TO JUSTICE INITIATIVE. ATJ SUPORTS LEGAL ASSISTANCE IN THREE AREAS: (A) UNDERSERVED AREAS, (B) HOUSING-RELATED MATTERS, AND (C) A SHARED LEGAL SERVICES INTERPRETER BANK. SINCE 2007, THE FOUNDATION HAS ADMINISTERED \$115,251,761 MILLION IN ATJ FUNDING TO PROVIDE CRITICAL LEGAL ASSISTANCE TO UNDERSERVED DC RESIDENTS WITH LOW INCOME.
