IN 2007, THE DC BAR FOUNDATION BEGAN AWARDED GRANTS UNDER THE ACCESS TO JUSTICE GRANTS PROGRAM (ATJ GRANTS) WHEN THE COUNCIL OF THE DISTRICT OF COLUMBIA DESIGNATED THE DC BAR FOUNDATION AS ADMINISTRATOR OF THESE FUNDS. ATJ GRANTS SUPPORT ORGANIZATIONS THAT PROVIDE LEGAL ASSISTANCE IN THREE AREAS: (A) UNDERSERVED AREAS IN DC; (B) HOUSING-RELATED MATTERS; AND (C) TO SUPPORT A SHARED LEGAL SERVICES INTERPRETER BANK. THESE PRIVATE GRANTS PROVIDE UNRESTRICTED FUNDS SUPPORT TO HELP COVER OVERHEAD COSTS, SUCH AS RENT AND CLIENT RECORD DATABASES, WHICH ARE NOT ALWAYS COVERED BY OTHER GRANTS THESE ORGANIZATIONS RECEIVE. THESE GRANTS ARE FUNDED BY PRIVATE CONTRIBUTIONS AND REVENUE RECEIVED THROUGH THE INTEREST ON LAWYERS TRUST ACCOUNTS (IOLTA) PROGRAM, A PROGRAM CREATED BY THE DISTRICT OF COLUMBIA COURT OF APPEALS IN 1985.
