LETTER FROM OUR CEO AND BOARD PRESIDENT

Dear Friends,

What a monumental year for the DC Bar Foundation! In keeping with the Foundation's mission and 42-year history to fund, support, and improve legal representation of people living in poverty and in vulnerable situations, or who are otherwise underserved in the District of Columbia, our accomplishments in 2019 further served to strengthen the civil legal aid network for District residents. We are excited by what was accomplished, and we hope you are too.

One of those accomplishments was launching an evaluation of the Civil Legal Counsel Projects Program, the Foundation's first-ever outcomes-based evaluation, to ensure more focused grantmaking that will lead to better results. This evaluation includes the participation of six grantees specifically serving clients facing evictions. Our goal is that the data collected will provide more accurate numbers of who is actually being served in the District and how. We look forward to releasing preliminary data reports on eviction in DC in 2020.

Second, the DC Bar Foundation awarded \$9 million to 26 DC legal aid organizations providing free legal assistance to thousands of DC residents with low incomes. This funding — in part made possible through more than \$2.0 million in revenue from Interest on Lawyer Trust Accounts funds — makes a significant and measurable impact in the lives of underserved District residents. From keeping people in their homes, to parents maintaining custody of their children, these funds are delivering justice to those who otherwise could not afford legal counsel. Additionally, we supported more than 80 legal aid attorneys through our Loan Repayment Assistance Program (see page 5).

Third, we adopted a bold new strategic goal for the next three fiscal years: "To transform the civil legal aid network, working closely with all stakeholders, so District residents have a fair and equal legal experience." This is a major shift from our previous strategic plan, which focused internally on financial growth, program efficiency, and becoming a model nonprofit. We are now moving toward an externally-focused goal that calls for transforming the legal aid network through increased engagement, greater collaboration, and measuring impact and outcomes.

We know that this work takes time and requires partnership. Nothing happens overnight, and nothing great can be done alone. Over the Foundation's 42-year history, many of you have stepped up and joined us in the work, whether from the very beginning, midway, or more recently. We thank you, for we could not do this work without you.

Although we have achieved much together, let us not become satisfied with things as they are. Many underserved District residents still do not receive the access to justice they deserve. This is our time to deliver more impact to those in our community who need us the most. Let's explore what more we can do together.


A FULL CIRCLE OF SUPPORT

AN OVERVIEW OF WHAT WE DO

The DC Bar Foundation (DCBF) works hand-in-hand with the civil legal aid community to better understand and address the legal issues facing District residents, identify unmet civil legal needs, and make strategic investments to strengthen and expand legal services for disadvantaged District residents. We are committed to the vision that District residents have equal access to justice, regardless of income.

GRANTS

The DC Bar Foundation assists our grantees with operational support funds as well as project funds. In 2019, we awarded **\$9.3 million** in funding which kept families in their homes, protected people in the marketplace and workplace, and amplified the voices of those in need. With this funding the Foundation supported a range of collaborative projects, including a shared legal interpreter bank and a coordinated intake and referral network for victims of crime.



LOAN REPAYMENT ASSISTANCE PROGRAM

The DC Bar Foundation's Loan Repayment Assistance Program (LRAP) is a pivotal recruitment tool for nonprofit legal aid organizations located in the District. LRAP provides eligible attorneys a **forgivable**, **one-year loan** to help pay their significant educational debt. LRAP makes it possible for poverty law attorneys to work in the legal aid sector, serve low-income District residents, and manage their student loan debt.

TRAINING AND TECHNICAL ASSISTANCE

The DC Bar Foundation invests in the capacity of the civil legal aid network through ongoing professional and organizational development opportunities such as eviction defense and trial skill building trainings for civil legal aid attorneys. For the first time, DCBF also **sponsored a racial justice training** for legal aid attorneys to advance racial equity in their work.

EVALUATION

The DC Bar Foundation partnered with the nationally renowned NPC Research to **launch DCBF's first outcomes-based evaluation**, focused on the Civil Legal Counsel Projects Program, our eviction defense grant program. The evaluation will quantify the program's impact in eviction defense, as well as recommend improvements to service delivery.

OUR STRATEGY, AT A GLANCE

The DC Bar Foundation spent much of 2019 developing our strategic plan for the next three years. With the support of SHG Advisors, we interviewed every DCBF Board member, surveyed our grantees, interviewed similar organizations, and conducted multiple staff-level meetings as well as a full day retreat with the Board of Directors. At its September 2019 meeting, DCBF's Board approved our new strategic goal:

Transform the civil legal aid network, working closely with all stakeholders, so District residents have a fair and equal legal experience.

To achieve this goal, the Foundation will employ the following strategies:

Engage all stakeholders in the work. We will facilitate increased collaboration between legal aid providers and the wider network of community-serving organizations. We know that people with low incomes experiencing a legal issue need services and support beyond just legal help.

Identify the unmet civil legal needs. We need to work directly with community members to identify their legal needs and with other organizations to ensure that the community knows where to go to get the legal help they need.

Infuse racial justice and equity in our work. We will evolve our practices to build a race equity culture within our organization and support our grantees as they go through their own journeys to become more equity-focused, all while advocating and partnering with organizations that promote racial justice in Washington, DC.

Fund with intention, making strategic investments to strengthen and expand legal services in DC. We will prioritize unmet civil legal needs and deliver more measurable value to those who need it, when they need it the most.

Demonstrate that people who need services are getting them. We will continue to build our – and our grantees' – capacity to use data to inform decision-making.

In 2019, our emerging strategy was most evident in the launch of the evaluation of the Civil Legal Counsel Projects Program. DCBF's first outcomes-based evaluation focuses on our eviction defense grantees. While intended to measure the impact of our grantmaking, it has also created a learning community – a network – of the CLCPP grantees. In partnership with NPC Research, a nationally renowned company based in Portland, OR, we are building our grantees' capacity to use data to learn about their clients, improve their service delivery, and strengthen their partnerships with each other.

These are big first steps in moving DCBF to be a different kind of grantmaker. If we want to go far, we must go together. With your support, we can and will do better for all residents of the District.

THOSE WHO SERVE - 2019 JERROLD SCOUTT PRIZE

In March, 2019, the DC Bar Foundation awarded the annual Jerrold Scoutt Prize to Daniel M. Clark, the Director of Rising for Justice's (formerly DC Law Students in Court) Civil Division and Co-Director of their Eviction Defense Services. Dan has dedicated over 20 years to DC's legal aid community, serving our underrepresented neighbors while teaching and mentoring the next generation of legal aid attorneys.

Throughout his career, Dan has held positions at the DC Bar Pro Bono Center's Bankruptcy Clinic and Landlord Tenant Resource Center, AARP Foundation, and the University of the District of Columbia David A. Clarke School of Law. In his current position with Rising for Justice, he directs their Civil Division as well as their Eviction Defense Services, where he has expanded the organization's services to several thousand more individuals.

The Jerrold Scoutt Prize was established by the firm of KMA Zuckert LLC (formerly Zuckert, Scoutt & Rasenberger LLP) in 1992 in honor of the public interest commitment of one of its founding partners, Jerrold Scoutt, Jr. It is awarded annually to an attorney who has worked for a significant portion of his or her career at a nonprofit organization providing direct hands-on legal services to the needy in the District of Columbia. Dan embodies the mission of the DC Bar Foundation. In the words of Seth A. Rosenthal, partner at Venable LLP and Chair of the Scoutt Prize Committee:

"Dan is a great lawyer who has spent nearly a quarter of a century working in the trenches to make a difference in the lives of District residents in need... He represents the best of our profession."



THIS IS WHAT JUSTICE LOOKS LIKE

It is extraordinary how one moment can change your whole life. For Rhonda, a former paralegal in Washington, DC, a routine trip through the city's notorious traffic catalyzed events that would make her a defendant in a lawsuit against a corporate giant.

"I was making good money. I was working two jobs. I was going back to school. I could afford to pay my monthly payments. I had a plan," she said. She was not financially wealthy, but she was content and comfortable.

Then, as she was driving, another car blindsided and injured her, forcing her out of work and into physical therapy. She was taking care of her mother at the time, so with her regular salary gone and her savings obliterated, Rhonda's bills were the Goliath to her very David income. In just months, she was notified that one of her creditors was suing her for \$10,000, the balance on a credit card plus exorbitant fees.

To fight the lawsuit, she knew she needed legal representation. Research shows that 90% of respondents who retain an attorney are more successful in legal proceedings. Rhonda contacted the Neighborhood Legal Services Program, a DC Bar Foundation grantee that provides free legal advice and representation to DC residents with low incomes. Attorney John Blake drafted a motion to dismiss and referred her to Tzedek DC, another DCBF grantee serving DC residents with low incomes.

Ariel Levinson-Waldman, Tzedek's president and director-counsel, represented Rhonda in court. He established that the creditor's attorneys had failed to comply with DC's service of process requirements and, in the end, the judge dismissed the case. The victory was an instant stress reliever for Rhonda.

"I felt hopeless. Fear stopped me from getting the help I needed right away," she explained. "I was so thankful to John and Ariel. They were very understanding and made me feel comfortable."



We are fortunate to have many steadfast donors and supporters who share our mission to provide access to justice for the District's poor and underserved. In 2019, we lost one of those supporters, and Washington DC's legal community lost a legend. Donald R. Dunner, partner at Finnegan Henderson Farabow Garrett & Dunner LLP, passed away at age 88.

In addition to his storied and successful career as a renowned patent attorney, Don was a lifelong friend and advisor to the DC Bar Foundation. He served on the Foundation's Advisory Committee since 1992, and as Chair of the Committee for the past 10 years. Don was also an active member of our Development Committee and was among the most dependable of our Volunteer Solicitors for our annual Call to Action campaign. On top of his service to the Foundation, Don was a steadfast financial supporter of our work for more than 25 years.

Paul Smith, President of the DC Bar Foundation, shared these words about Don: "He was absolutely dedicated to making sure the Foundation had the funds it needed to help fund legal services for the poor in DC. We will miss his cheerful enthusiasm."

We are extremely grateful for Don's support of the Foundation and DC's civil legal aid community as a whole. Most importantly, however, we are grateful for his loyalty and friendship and will miss him dearly.






GRANTS
